This clarification text is the data controller of your personal data, Sevenn Group Logistics Ltd. Sti. ("Sevenn Group").

## **Personal Data Processing Purposes and Legal Reasons**

Your personal data is processed based on the legal reasons specified in Article 5 of the Law on the Protection of Personal Data ("Law"). The following are the purposes for which we process your data and the legal grounds:

- Your data is processed for the purposes of protecting and exercising our rights and carrying out legal processes in case of a possible legal dispute, based on the legal reason of "establishment, exercise or protection of a right".
- Your data is processed for the purpose of fulfilling our legal obligations (for example, sharing your information in case a public institution requests a transaction suspected of unlawful transactions) in cases where authorized institutions or organizations make a request from our Company based on the legal reason of "fulfillment of our legal obligations" or where we are expected to notify these institutions.
- Your data is processed for the purposes of conducting communication processes, receiving and concluding feedback/requests/complaints, managing customer relations, carrying out processes for the improvement and development of our business activities, and examining and auditing our business activities, based on the legal reason that "data processing is mandatory for our legitimate interests".
- Your data is processed for the purpose of making promotions and other marketing communications in accordance with your communication permission preferences, in case you want to be informed about campaigns and events and special opportunities for you "if you provide your explicit consent".

## **Processed Personal Data**

Sevenn Group Logistics processes your personal data regarding your identity, contact, company information and feedback/request/complaint. In addition, your transaction security information is also processed within the scope of your visit to our website.

## **Transfer of Personal Data**

In order to fulfill the purposes set forth in this clarification text, your personal data may be processed by suppliers and business partners, our group companies, authorized persons, institutions and organizations, based on the legal reasons mentioned above, in accordance with Article 8 of the Law on the Protection of Personal Data and

It is shared within the rules regarding the transfer of personal data specified in Article 9.

## **Personal Data Collection Methods and Legal Reasons**

Your personal data is collected through the contact form on our website. The methods in which we collect your personal data are automatic and partially automated. We collect your personal data based on the legal reasons specified in Articles 5 and 6 of the Law on the Protection of Personal Data, the fulfillment of our legal obligations, the establishment and exercise of a right, and the legal reasons that data processing is mandatory for our legitimate interests, provided that it does not harm the fundamental rights and freedoms of the person concerned. When there is no at least one of the legal reasons specified in the Law, your explicit consent is asked for the processing of your data.
